Paper Selection and Publication Process

- a) Upon receipt of paper submission, the editor sends an E-mail of conformation to the corresponding author within 1-3 working days. If you fail to receive this conformation, your submission/e-mail may be missed. Please contact the Editor in time for that.
- b) Peer review. We use double-blind system for peer-review, both reviews and authors' identities remain anonymous. The paper will be peer-reviewed by three experts, one is an editorial staff and the other two are external reviewers. The review process may take 2-3 weeks.
- c) Notification of the results of review by E-mail to into the authors to revise paper.
- d) After publication, the corresponding author will receive one copy of printed journal and one soft copy of journal, free of charge.

The seven manuscripts in this JMSET Journal (Volume 4, Issue No. 1) present an indepth discussion on latest fields of Applied and Environmental Sciences.

In first paper is a measuring the urban growth in Khoms, Libya, by using geographic information systems and remote sensing.
